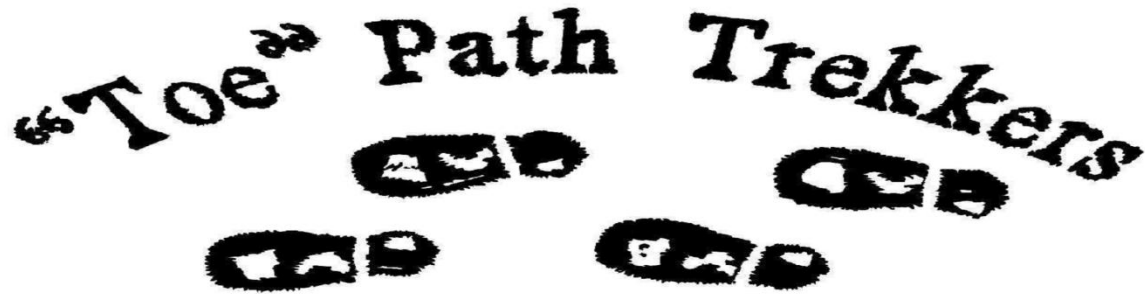
**START TIMES:** 5K/10K 10:00AM
